- 2. In Compliance with Regulation 13 (2)(d) of Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulation 2016, a list of creditors along with amount claimed, claims admitted, Security interest in respect of claims as on 28-3-2022 is enclosed at Annexure A.
- 3. The director of the CD has preferred Company Appeal (AT) (Ins) 820 of 2021 before Hon'ble NCLAT, New Delhi, pleading withdrawal of CIRP proceedings due to settlement with the applicant. During the course of hearing, parties entered into settlement and appellant agreed to withdraw the appeal. Hon'ble NCLAT vide its order dated January 5, 2022 observed that, it is open for the parties to file settlement terms copy with Adjudicating Authority and to seek appropriate authority.
- 4. Applicant SBI Cap Trustee securities accordingly filed form FA (u/S 12 A of IBC, 2016) through undersigned which was registered as IA no. 122 of 2022. It was opposed by one of the creditors viz. Piramal Capital & Housing Finance Ltd. by filing IA no. 164 of 2022.

- 5. Hon'ble NCLT Mumbai vide its order pronounced on 28th March, 2022 upheld the objection and dismissed the withdrawal application. Copy of the order is awaited
- 6. Hence latest list of creditors as on 28th March, 2022 is again filed.
